- 0 inmates were removed from the UDS count by natural death.
- 2 inmates had their sentence commuted or overturned.

***On June 21, 2019, The Georgia Department of Corrections had 46 UDS cases. Only inmates in the physical custody of the department will be displayed. Some inmates under death sentence may be in the custody of other jurisdictions, or “out to court” in the original jurisdiction of conviction. This list includes those inmates who are awaiting resentencing trial and those awaiting retrial.***

***Male UDS inmates are housed at Georgia Diagnostic & Classification Prison and female UDS inmates are housed at Arrendale State Prison.***

***Under Georgia law, there are three offenses that are punishable by death. Those crimes are Murder, Rape and Kidnapping.***
