Chairman Jerry Willis called the February meeting of the Board of Corrections to order at 10:00 a.m. and Board Liaison, Simone Juhmi, recorded the minutes.

Chairman Willis confirmed that Board Member Mike Coggins was connected via conference call. Chairman Willis asked Chaplain Steven Turner to deliver the invocation.

Chairman Willis led the Pledge of Allegiance and recognized all guests and visitors and the Board meeting, having been duly convened, was ready to proceed to business.

Chairman Willis presented the February Agenda to the Board for approval. Mr. Wayne Dasher made the motion to approve, which was then seconded by Ms. Rose Williams, and the Agenda was voted approved by the Board as presented.

Chairman Willis presented the January Minutes to the Board for approval. Mr. Wayne Dasher made the motion to approve, which was then seconded by Ms. Rocio Woody, and the Minutes were voted approved by the Board as presented.

### **COMMISSIONER'S REPORT**

Commissioner Gregory C. Dozier began his report by presenting a brief summary of the Commissioner's dashboard, which is a three-page overview highlighting key areas within the agency.

Next, Chairman Jerry Willis briefly showed the Board members his personal port authority legacy jacket, while stating that the jacket was durable and convenient. Each member was offered an opportunity to order a jacket if they chose to do so. To follow, Commissioner Dozier asked Ms. Joan Heath, Director of Public Affairs, to introduce the "Beyond the Walls" article and short video on Mr. Jeremy McClure. Mr. McClure was incarcerated for 13 years and was sent to Augusta Transitional Center, wherein he was afforded the opportunity to receive on-the-job training with the company that took a chance on him when he was nearing release. Mr. McClure worked as an electrician with GDC's Mobile Construction unit across the state, and it was through the Department of Corrections Transitional Program, that he was allowed to go back into society, get a job, and reacclimate himself.

Afterwards, Commissioner Dozier introduced Ms. Amy Pataluna, Interim Executive Director, Georgia Correctional Industries, to present a Georgia Correctional Industries Update. Ms.

Pataluna began by discussing the administrative alignment which included the administrative responsibilities and the goals and benefits for Correctional Industries. In addition, Ms. Pataluna introduced Mr. Alan Watson, Deputy Director, Administration and Finance Division, to discuss the process update priorities for Correctional Industries. Mr. Watson discussed the State Purchasing Card (P-Card) Program, Purchasing Procedures, Asset Management, and Product Analysis. To close, Ms. Pataluna discussed the next steps for training – financial processes, inventory management, staffing analysis, and business process analysis to develop a strategic plan for Correctional Industries.

Thereafter, Mr. Jay Sanders, Assistant Commissioner of Inmate Services Division, presented the "Beyond the Call" employee recognition plaque on behalf of the Board of Corrections and Commissioner Gregory C. Dozier to Mr. Cliff Hartley, Field Services, Transitional Services Unit. A photo was taken of the plaque presentation.
