First, Chairman Larry Haynie called to order the May meeting for the Board of Corrections (“the Board”) at 10:00 a.m. and Board Liaison, Simone Juhmi, recorded the minutes. Chairman Haynie

then asked Chaplain Steven Turner to deliver the invocation. Following such, Chairman Haynie led everyone in the Pledge of Allegiance.

Chairman Haynie welcomed and recognized all guests and visitors, and the Board meeting, being duly convened, proceeded with business.

Chairman Haynie then confirmed the following individuals were present via conference call: Board Members Ms. Janelle King, Mr. Lou Solis Jr., and Ms. Rose Williams.

Chairman Haynie presented the May 2, 2024 Agenda to the Board for approval. Mr. Ester Fleming Jr. made a motion to approve the Agenda, which was seconded by Mr. Thomas Culpepper. The Agenda was voted “approved” by the Board as presented.

Chairman Haynie presented the April 4, 2024 Minutes to the Board for approval. Mr. W.D. Strickland made the motion to approve the Minutes, which was seconded by Mr. Rossie Ross. The Minutes were voted “approved” by the Board as presented.

### **COMMISSIONER’S REPORT**

To begin the Commissioner’s Report, Commissioner Tyrone Oliver discussed Healthcare, CLA on the Hill, Washington County, the Senior Leadership Offsite, Senator Albers visit to Smith State Prison, and Officer Robert Clark’s recognition and tribute in other states.

To close, Commissioner Oliver asked Mr. Antoine Caldwell, North Regional Director, to assist in introducing and honoring four (4) correctional officers (Nilelaya Barnes, Correctional Officer II, Central State Prison; Chandra Calton, Sergeant, Dodge State Prison; Reginald Gantt, Correctional Officer III, Burruss CTC; Kimberly Stewart, Lieutenant, Hays State Prison) with a Commissioner’s coin for Correctional Officers Week. In addition, the Board of Corrections honors the service of correctional officers each year by presenting a Governor’s proclamation to a select group. Correctional Officers Week will be celebrated the week of May 7-11<sup>th</sup>, 2024. Individual photos were taken of each officer’s presentation.

Commissioner Oliver asked Mr. Randy Sauls, Assistant Commissioner, Office of Health Services, to assist in honoring four (4) Nurses (Donna Drago, Health Services Administrator, Baldwin State Prison; Rachel Hatch, Health Service Administrator, Walker State Prison; Bethany Hilliard, Director of Nursing, Dodge State Prison; Armanda Williams, Licensed Practical Nurse, Wilcox State Prison) for National Nurses Week. The Board of Corrections honors these nurses for the vital role they play in the correctional health setting each day. The nurses were presented with a Governor’s proclamation and a Commissioner’s coin. National Nurses Week will be celebrated the week of May 6 – 12, 2024. Individual photos were taken of the presentations.

This concluded the Commissioner’s Report.

### **CHAIRMAN’S REPORT**

Under the Chairman’s Report, Chairman Haynie began by advising the Board that we collected a total of one thousand four hundred sixty dollars (\$1460.00) towards the 2024 Georgia Prison Warden’s Association Board of Corrections scholarship fund. The Board will continue to collect for this scholarship until the fifteen-hundred-dollar (\$1,500) goal is met.

Chairman Haynie then discussed the 2024 Board Calendar advising that he would like to change and update the June 6th meeting from Ringgold, Georgia to Rome, Georgia, since we were not able to secure a location in Ringgold.

Chairman Haynie asked for a motion to approve the new location. Mr. Thomas Culpepper made the motion, which was seconded by Mr. J. C. “Spud” Bowen. The motion was voted “approved” by the Board as presented.

Next Chairman Haynie continued the Chairman’s Report by moving into Regular Session to approve a County Warden and a County Deputy Warden’s appointment.

Chairman Haynie called upon Mr. Duke Blackburn, who is the Chairman of the Board Facilities Committee, to give the Board the Committee's recommendation on Mr. Luther Minix and Mr. Murray Tatum.

Mr. Blackburn stated that he would like to do both candidates at one time in one vote. Mr. Blackburn stated that the Committee received the report on Mr. Luther Minix – Warden of Jackson County Correctional Institution, and the Committee reviewed his report and would like to make a motion to approve Mr. Minix's appointment as the Warden of Jackson County Correctional Facility.

In addition, Mr. Blackburn stated that the Committee received the report on Mr. Murray Tatum – Deputy Warden of Jackson County Correctional Institution, and the Committee reviewed his report and would like to make a motion to approve Mr. Tatum's appointment as the Deputy Warden of Jackson County Correctional Facility.

Mr. Blackburn made the motion to approve both appointments and stated that the entire Committee formally recommended approval so there was not a need for a seconded motion. The motion were voted "approved" by the Board as presented.

Chairman Haynie congratulated Mr. Minix and Mr. Tatum, and both candidates thanked the Board for the opportunity.

There was no Old or New Business so Chairman Haynie asked to take a vote to go into Executive Session so that the Board may consult with legal counsel pertaining to potential litigation. Mr. Rossie Ross made a motion to move into Executive Session, which was seconded by Mr. W.D. Strickland and Mr. Thomas Culpepper. The vote for the Board to move into Executive Session were voted "approved" by the Board.

Chairman Haynie asked for a motion to approve moving out of Executive Session. Mr. J. C. "Spud" Bowen made the motion to approve, which was seconded by Mr. Thomas Culpepper. The vote for the Board to move out of Executive Session were voted "approved" by the Board.

Chairman Haynie asked for a motion to approve moving back into Regular Session. Mr. Alton Russell made the motion to approve, which was seconded by Mr. J. C. "Spud" Bowen. The vote for the Board to move back into Regular Session were voted "approved" by the Board.

Chairman Haynie reminded the Board about the Board Luncheon honoring Correctional Officers and Nurses following the board meeting. Chairman Haynie also reminded the Board that the June 6, 2024 board meeting will be in Rome, Georgia at the Forum River Center.

There being no further business, the board meeting was adjourned.
