Chairman Rose Williams called the October meeting of the Board of Corrections to order at 10:30 a.m. and Board Liaison, Simone Juhmi, recorded the minutes. Chairman Williams asked Chaplain Lester Foster to give the invocation.

Chairman Williams led the Pledge of Allegiance, recognized all guests and visitors and the Board meeting, having been duly convened, was ready to proceed to business.

Chairman Williams recognized Mr. Lee Beckmann, Manager of Governmental Affairs with the Georgia Ports Authority. Mr. Beckmann gave a brief overview about the history of the port and showed a five minute video of the daily operations.

Next, Chairman Williams presented the October Agenda to the Board for approval. Mr. Wayne Dasher made the motion to approve, which was then seconded by Sheriff Roger Garrison and the Agenda was voted approved by the Board as presented.

Chairman Williams presented the September Minutes to the Board for approval. Mr. Wayne Dasher made the motion to approve, which was then seconded by Ms. Sonja Allen-Smith and the Minutes were voted approved by the Board as presented.

COMMISSIONER'S REPORT

Commissioner Homer Bryson began his report stating the Upcoming Events calendar is located in the back of the booklets for review and members can attend any up-coming event or graduation. Next, Commissioner Bryson presented a three page overview PowerPoint highlighting keys areas within the agency such as inmate population, inmate security levels, bed utilization, safe and secure facilities, inmate services, fire services and contraband, specifically cell phones. Commissioner Bryson noted that cell phones in prisons are a huge national issue. In mid-October, the Department of Corrections is meeting with the FCC in reference to cellphones and we hope Corrections will be able to get permission from the FCC to use "jamming" technology. Commissioner Bryson then spoke briefly on the welding program, diesel mechanic program, OJT program, volunteer services and chaplaincy services.

Next, Assistant Commissioner L.C. "Buster" Evans gave an Inmate Services update covering areas within his division such as academic education, vocational education, chaplaincy, risk reduction, reentry services and health services. Dr. Evans stated his role over Inmate Services enables him to visit and speak at several facilities and meet staff as well as people that are incarcerated. As a result, while visiting Baldwin State Prison, Dr. Evans met Ms. Donna Payne who invited him to come and speak to the Lifers group at Baldwin State Prison. Dr. Evans stated that he was impressed with Ms. Payne's leadership structure and her willingness to go above and beyond the call of duty. Dr. Evans explained that Ms. Payne helped organize the program by creating a curriculum and he believes she found her passion in doing this.

Likewise, while visiting Baldwin State Prison, Dr. Evans met Tracy Xavier Hickey who had a story that captures the heart and soul of the ability of this group of people to make a positive difference in our facilities. Dr. Evans stated Mr. Hickey has a powerful and positive influence on the culture inside Baldwin State Prison that helps positively change the culture. Dr. Evans then showed a video from the Baldwin State Prison Lifers Program called "Reducing Recidivism through Education."

Immediately following, Assistant Commissioner Timothy C. Ward presented the area and functions of the Facilities Operations Division. Mr. Ward stated in his role over the Facilities Division, he is responsible for the Communication Center, Emergency Management Operations, Fire Services, and Life Safety Services. Mr. Ward explained that the Facilities Operations Division restructured around 4 basic functions (Field Operations, Planning, Support, and Analysis, Special Operations and Communication Center) with an emphasis on regionalizing field operations. To conclude, Mr. Ward displayed an organizational chart for the Facilities Operations Division.

Next, Mr. Artis Singleton, Warden of Lee State Prison, presented a facility overview. Warden Singleton began his presentation with the general history of Lee State Prison, the mission statement and motto of the facility. Some highlights discussed were the inmate population numbers, staffing, Evidence Based Facility, programs offered, Education-GED, ABE, LR/R, Cognitive programs, Substance Abuse, Self-help groups and Electives.

Subsequently, Assistant Commissioner Timothy C. Ward presented an Employee Recognition plaque on behalf of the Board of Corrections and Commissioner Homer Bryson to Ms. Donna

Payne of Baldwin State Prison. The plaque was given to Ms. Payne for "Going Above and Beyond the Call of Duty." A photo was taken of the plaque presentation.

This concluded the Commissioner's Report.
