First, Vice Chairman Ester Fleming Jr. called to order the September meeting for the Board of Corrections ("the Board") at 10:00 a.m. and Board Liaison, Simone Juhmi, recorded the minutes.

Vice Chairman Fleming then asked Chaplain Kenneth Ellis to deliver the invocation. Following such, Vice Chairman Fleming led everyone in the Pledge of Allegiance.

Vice Chairman Fleming welcomed and recognized all guests and visitors and the Board meeting, being duly convened, proceeded with business.

Vice Chairman Fleming presented the September 5, 2024 Agenda to the Board for approval. Mr. W. D. Strickland made a motion to approve the Agenda, which was seconded by Mr. Rossie Ross. The Agenda was voted "approved" by the Board as presented.

Vice Chairman Fleming presented the August 8th Special Called Minutes to the Board for approval. Mr. Thomas Culpepper made the motion to approve the Minutes, which was seconded by Mr. W. D. Strickland and Mr. Rossie Ross. The Minutes were voted "approved" by the Board as presented.

COMMISSIONER'S REPORT

To begin the Commissioner's Report, Commissioner Tyrone Oliver gave condolences for the Barrow County, Georgia school shooting victims and then he discussed briefly the Commissioner's Dashboard, which is a four-page overview highlighting key areas and significant events within the Agency.

Commissioner Oliver asked Ms. Catherine Price, Statewide Compliance and Accreditation Manager, to present the American Correctional Association Recognitions and Update. Ms. Price discussed the Compliance staff and their key roles, the initial one-year process for accreditation, the three-year reoccurring reaccreditation process, the accreditation summary for prisons, probation detention centers, transitional centers, and the agency accreditation average for the 49 sites.

Commissioner Oliver asked Mr. Adam Baswell, Director of the Office of Professional Development, to present a Regional Academies Update. Mr. Baswell began by discussing the Basic Correctional Officer Training program, the requirements established by the Georgia Department of Corrections and the Georgia Peace Officer Standards Training Council for new Correctional Officers, and other staff who supervise offenders as a part of their normal duties in state, county, and private facilities.

Mr. Baswell also discussed the Office of Professional Development starting the Regional Academy concept in August 2023, and the various locations (State Offices South Tift College Georgia Corrections Academy, Northeast Georgia Corrections Academy, Southeast Georgia Corrections Academy, Middle Georgia Corrections Academy, and the Southwest Georgia Corrections Academy).

Mr. Baswell closed with discussing the Success Coaching program providing one-on-one personalized assistance to cadets attending the Basic Correctional Officer Training academies and Mr. Baswell showed a Success Coaching Program Testimonial video.

This concluded the Commissioner's Report.

CHAIRMAN'S REPORT

Under the Chairman's Report, Vice Chairman Fleming began by giving a final update on the 2024 Board of Corrections Georgia Prison Warden's Association scholarship fund.

Vice Chairman Fleming advised the Board that the \$1,500 dollar goal was surpassed and that the Board collected a total of \$1,600 dollars this year. In addition, Secretary J.C. "Spud" Bowen stated that he would like the scholarship fund to be raised to \$2,000 or \$2,500, and going forward, to rename the Board of Corrections Scholarship Fund to honor former Chairman Larry Haynie, thus changing the name to the "Larry Haynie Board of Corrections Scholarship Fund." There was no discussion or motion, and all members agreed with these changes.

Further, Vice Chairman Fleming stated the 2024 Board of Corrections scholarship recipient is Taylor Alexander. Taylor is the daughter of Danielle Richardson who works at Burruss Correctional Training Center. Taylor is now a Certified Nursing Assistant and will be attending Kennesaw State University in the Fall pursing her degree in Nursing.

Vice Chairman Fleming briefly discussed the October board meeting being held in Statesboro, Georgia.

Vice Chairman Fleming then asked for a motion to approve an honorary resolution celebrating the retirement of former Director of Field Operations, Stan Shepard, for his dedication and commitment to the Georgia Department of Corrections.

Vice Chairman Fleming asked for a motion to approve the resolution. Mr. Alton Russell made a motion to approve the resolution, which was seconded by Mr. Rossie Ross. The resolution were voted "approved" by the Board as presented.

Under Old or New Business, Vice Chairman Fleming stated that he decided to give the board members the 2025 Committee Requests nomination sheets earlier so that the Board could fill out their requests for the upcoming year. All members were asked to fill the forms out so that they can be reviewed for the 2025 Executive Officer positions.

Last on the agenda, Vice Chaiman Fleming asked Ms. Janine Robinson, Director of Administrative Support Division, Fleet Operations and Risk Management, to present an approval of employment for one (1) Fleet Operations Mechanic 2.

Ms. Robinson began by stating that Mr. Brian Meadows - (GDC Fleet Mechanic 2's) specific job duties as defined by Standard Occupational Classification Manual, will include the following:

49-3023: Automotive Service Technicians and Mechanics: Diagnose, adjust, repair, or overhaul automotive vehicles.

49-3093: Tire Repairers and Changers: Repair and replace tires.

51-4121 Welders, Cutters, Solderers, and Brazers: Use hand-welding, flame-cutting, hand-soldering, or brazing equipment to weld or join metal components or to fill holes, indentations, or seams of fabricated metal products.

49-2096: Electronic equipment installers and repairers, motor vehicles: Install, diagnose, or repair communications, sound, security, or navigation equipment in motor vehicles.

Ms. Robinson stated Mr. Meadows is an Automotive Academy graduate who has been on the Fleet detail for almost 2 years. He is eligible and Fleet would like to hire him.
