The Facilities Division is responsible for the direct supervision of all offenders sentenced to the Georgia Department of Corrections. There are four female state prisons: one medical facility, which houses pregnant offenders, two treatment facilities, and one Probation Detention Center.

INFORMATIONAL HIGHLIGHTS



FACTS

- Children of female offenders are seven times more likely to become incarcerated than those of the non-incarcerated females
- Female offenders report leaving behind one to 10 children in the care of others during incarceration
- Pathways to crime include a long history of sexual and/or physical abuse, trauma, unhealthy relationships or substance use:
 - Approximately 50% were physically abused
 - Approximately 45% have a history of sexual abuse
 - 75% had drugs involved in convictions

BLECKLEY RESIDENTIAL SUBSTANCE ABUSE TREATMENT FACILITY

The facility opened in August 2004 as a Probation Detention Center. In 2015, it was remissioned to a Residential Substance Abuse Treatment Facility with 208 beds.

WOMEN'S PROBATION DETENTION CENTER

The facility opened in 1992. All detainees entering the center arrive by the county Sheriff's Office and are evaluated by medical, mental health, and counseling staff to determine placement. The facility has a 237 bed capacity.

LEE ARRENDALE STATE PRISON

INFORMATIONAL HIGHLIGHTS

DIAGNOSTIC FACILITY

- Opened in 1951 and renovated in 1999
- Special mission facility with a capacity of 1,854
- All female offenders must be processed through the facility when entering the state system
- Offenders are evaluated by medical, mental health and receive academic testing to determine placement

PROBATION RSAT

Probation RSAT is a nine month four-phase program that houses 198 probationers and is utilized by the judicial court system.

STRATEGIC INTERVENTION PROGRAM

This collaborative program between the Department of Corrections and Parole provides evidence-based programming to nonviolent offenders with less than five years to serve.

MENTAL HEALTH PROGRAM

Provides services to Mental Health Level II offenders, and houses MH Level III and IV offenders in a specialized living unit.

FIRE STATION NO. 1

Fire Station Number 1 is the nation's only all-female firefighting team consisting of 12 firefighters who receive state of Georgia certification. The Fire team responds to an average of 100 calls per year in Banks, Habersham and White counties and has an automatic aid contract with the City of Baldwin.

LEE ARRENDALE TRANSITIONAL CENTER

Lee Arrendale Transitional Center Is a 140-bed center located on the property of LASP. Eligible offenders, who are approximately 15 months of release, work within the community to obtain employment, transportation, and safe, affordable housing once released.

EMANUEL WOMEN'S FACILITY

The facility opened in 1996 and was renovated in 2011. It is a medium-security facility with a population capacity of 415 and is the host facility for the Emanuel Probation Detention Center. It is the first female facility in the state to teach inmates Braille, which began July 1, 2018.

WEST CENTRAL INTEGRATED TREATMENT FACILITY

The facility opened in 2012 and was remissioned from a pre-release center to an Integrated Treatment Facility (ITF) in July 2012. It is a medium-security facility with a capacity of 194.

INTEGRATED TREATMENT PROGRAM

- Houses 138 female offenders with co-occurring disorders, and also houses 46 female probation offender to work on contract details.
- Nine-month, four-phase substance use recovery and mental health stabilization program provided by Spectrum Health Services
- Before release, the offender and field probation officer will develop an aftercare program within the offender's community
