Georgia Correctional Industries (GCI) is an integral part of the Georgia Department of Corrections, employing approximately 1,000 offenders. During their incarceration, offenders are provided opportunities to enhance key attributes needed to obtain employment upon release. GCI plays a valuable role in this process by providing job opportunities within one of our three divisions: Manufacturing, Food Service, and Agribusiness.

EMERGENCY RESPONSE CAPABILITIES

GCI is privileged to have their own emergency response equipment allowing them to respond when needed.

This equipment is used for the following:

- Kitchen construction projects
- GDC emergencies such as loss of power, water, or other resources
- State of emergencies to support the needs of the Georgia Emergency Management Agency or other agencies

GCI's emergency response equipment includes:

- Two mobile kitchens with the ability to feed up to 1,700 people
- One mobile kitchen with the ability to feed up to 450 people
- Two prep trailers with the ability to support the mobile kitchens
- Two generators
- One 6,500-gallon water tanker for potable water

Food Service and Agribusiness

GCI Food Service and Agribusiness programs produce 42% (FY 21) of the food items utilized within the offender menu, with products privileged to carry the Georgia Grown Label. Production facilities include dairy, meat and egg processing units, cannery, and grist mill. Emphasis is placed on efficient farm operations, distribution, warehousing, and food preparation. Major production enterprises include beef, dairy, vegetables, eggs, grits, and cornmeal.

FOOD SERVICES

Provides oversight and management of GDC Food Service Operations. Offender menus provided: regular, alternative entree program (religious diet program), and medically prescribed diets. Providing over 39 million (FY21) offender meals annually.

RUTLAND CAFETERIA, STATE OFFICES AT TIFT COLLEGE (FORSYTH)

- Provides on-site food service to training, cadets, staff, and visitors

FOOD DISTRIBUTION UNIT (MILLEDGEVILLE)

- Meat processing, GCI transportation hub, warehousing and distribution unit for statewide food service operations

AGRIBUSINESS OPERATIONS

Each year, GCI's agriculture programs provide the opportunity for more than 300 offenders to work in farm operations located across the state.

LEE ARRENDALE STATE PRISON FARM

Alto, Ga - 596 Acres

- Beef Unit: 200 head commercial cow/calf operation
- On-site feed mill: 30,000-bushel storage capacity
- Hay Production

DOOLY STATE PRISON FARM

Unadilla, Ga - 125 Acres

- Vegetable & fruit
- Beef Unit: 40 head brood cow operation {March 2022}
- Hay Production

JOE KENNEDY FARM

Lyons, Ga - 2,600 Acres

- Offender labor provided by Montgomery SP
- Gristmill (grits and cornmeal)
- Average 1,600 head of background steer and heifers annually
- 200 head of brood cows
- Row crops: corn, wheat, cotton and winter grazing grasses
- On-site feed mill: 60,000-bushel storage capacity
- Hay Production

MIDDLE GEORGIA FARM

Davisboro and Milledgeville, Ga - 1,100 Acres

- Beef Unit: 450 head brood cows
- Winter grazing grasses for livestock
- Hay Production

MONTGOMERY STATE PRISON FARM

Mount Vernon, Ga - 65 Acres

- Egg production facility, fresh and frozen egg products
- 120,000 hen laying operation
- On-site feed mill: 100,000-bushel storage capacity

ROGERS STATE PRISON FARM

Reidsville, Ga - 9,400 Acres

- Beef Unit: 1,150 head brood cows
- Dairy Unit: Average 165 cows milked daily
- Canned Vegetable Unit: carrots, collards, kale, Irish potatoes, sweet potatoes, squash, and turnips
- Fresh Vegetable Unit: cabbage, broccoli, greens, watermelon, cantaloupe, cucumbers, tomatoes, squash, sweet corn, bell peppers, okra, potatoes
- Row Crops: corn, cotton, peanuts, soybeans, wheat, and winter grazing grasses
- On-site feed mill with over 150,000-bushel storage capacity
- Two food processing units - canning & dairy
- Hay Production
