

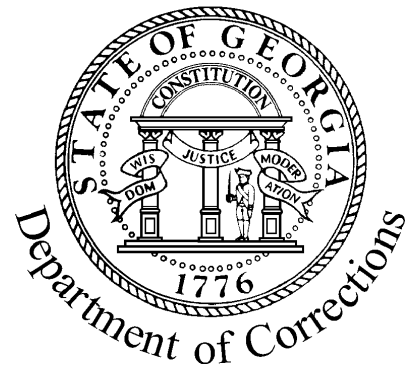

Changes to UDS Population 2010

During 2010, the following changes were made to the UDS population:

- 2 new inmates were added.
- 3 inmates were executed by means of lethal injection.
- 1 inmate was removed from the UDS count by natural death.
- 1 inmate had their sentence commuted.

On January 1, 2011, The Georgia Department of Corrections had 100 UDS cases. Only inmates in the physical custody of the department will be displayed. Some inmates under death sentence may be in the custody of other jurisdictions, or “out to court” in the original jurisdiction of conviction.

Males UDS inmates are housed at Georgia Diagnostic & Classification Prison and female UDS inmates are housed at Metro State Prison. (NOTE: As of June 1, 2011, females are housed at Arrendale State Prison.)

Under Georgia law, there are three offenses that are punishable by death. Those crimes are Murder, Rape and Kidnapping.
