**Note 1 - Total Costs:** Includes proration of Central Office costs, i.e., Commissioner's Office, Accounting, Payroll, Personnel and Inmate record keeping, etc. Total costs were used in calculations except in the "STATE ONLY" columns.

**Note 2 - County Correctional Institutions and Jail Subsidies:**

- GDC paid \$22.00 per day **per** inmate assigned to a County Correctional Institution (increased to \$24.00 per day as of April 2024)
- GDC paid \$30.00 per day **per** sentenced inmate awaiting pick-up in county jails beyond day 15.

**Non-State Funds that are included in the above total (except for the columns labeled "STATE ONLY").**

- Federal Funds (DOJ Grants, Education Grants, etc.): \$5,599,620.55
- Inmate Store and Central Project Telephone Funds: \$17,997,201.75
- Construction Projects (Bonds): \$35,726,163 and Insurance Recoveries: \$1,086,331.83
- Details (DOT, county, city): \$1,945,184.32
- Various (sick call, inmate fees, employee payments, recycling, miscellaneous, etc.): \$3,603,102.27
